Unfortunately, due to my unemployment, my wife will no longer be able to manage these financial obligations on her own.

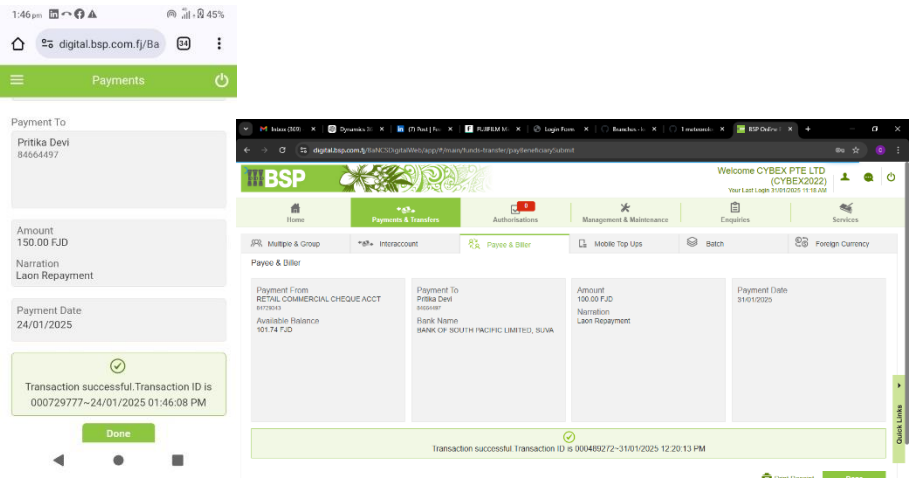
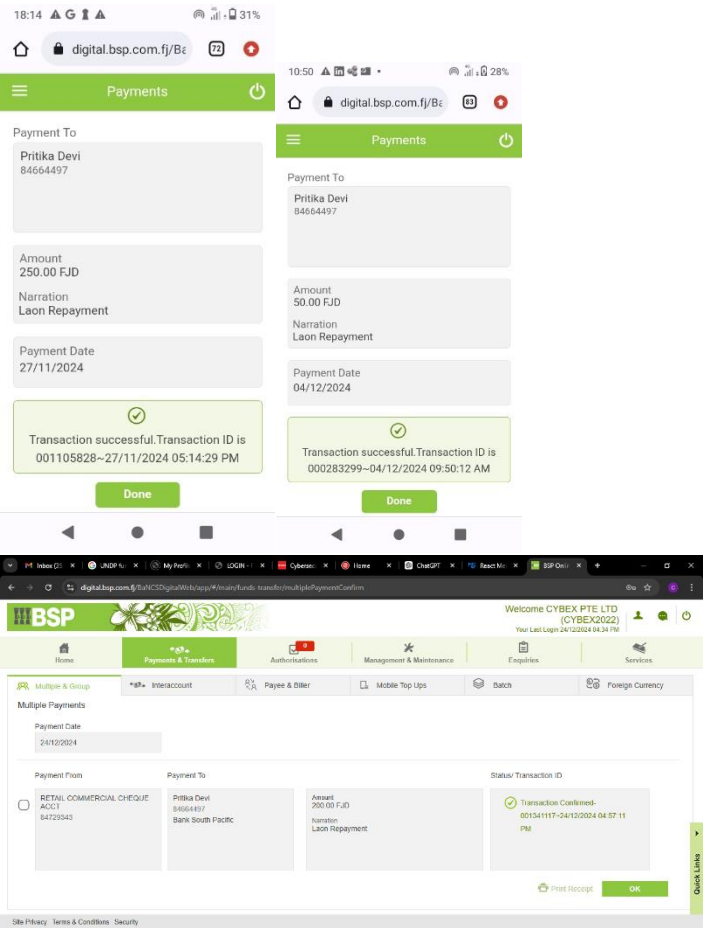

Thank you for your understanding and consideration.

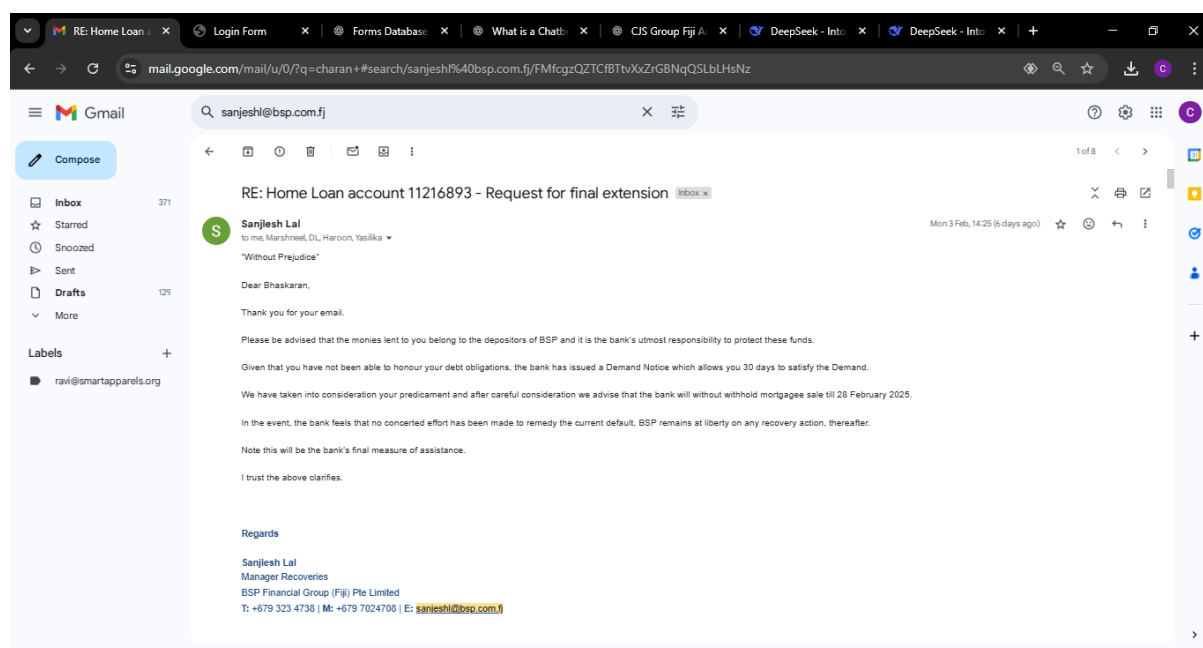

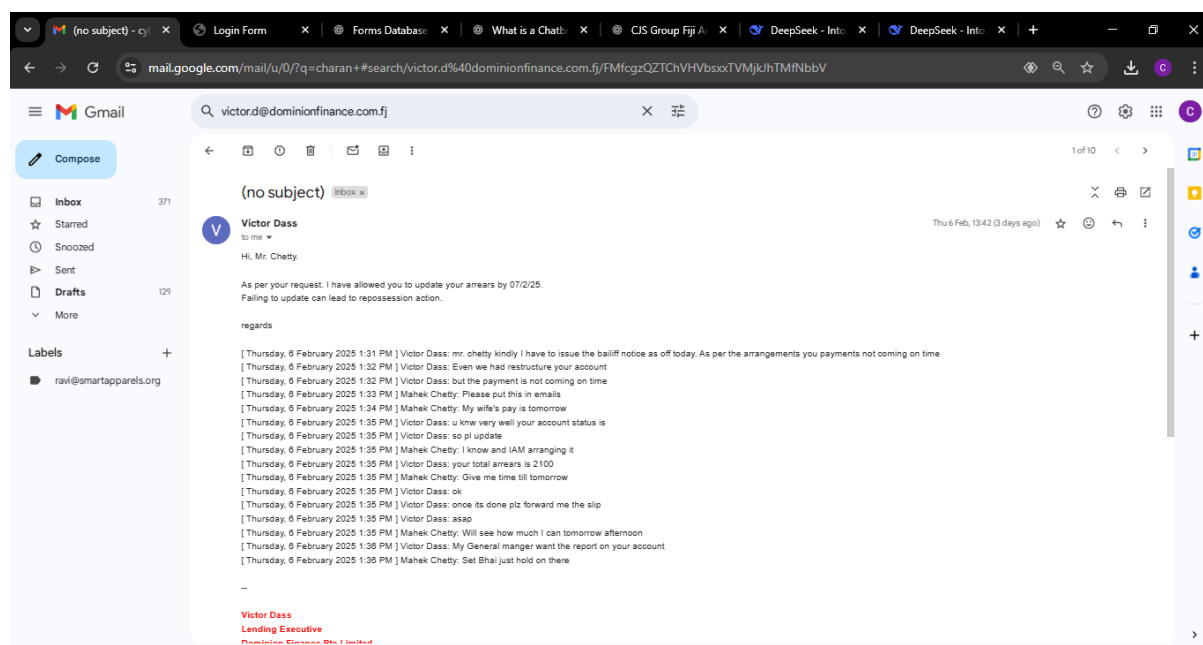
Evidence of Payment: November, December and January



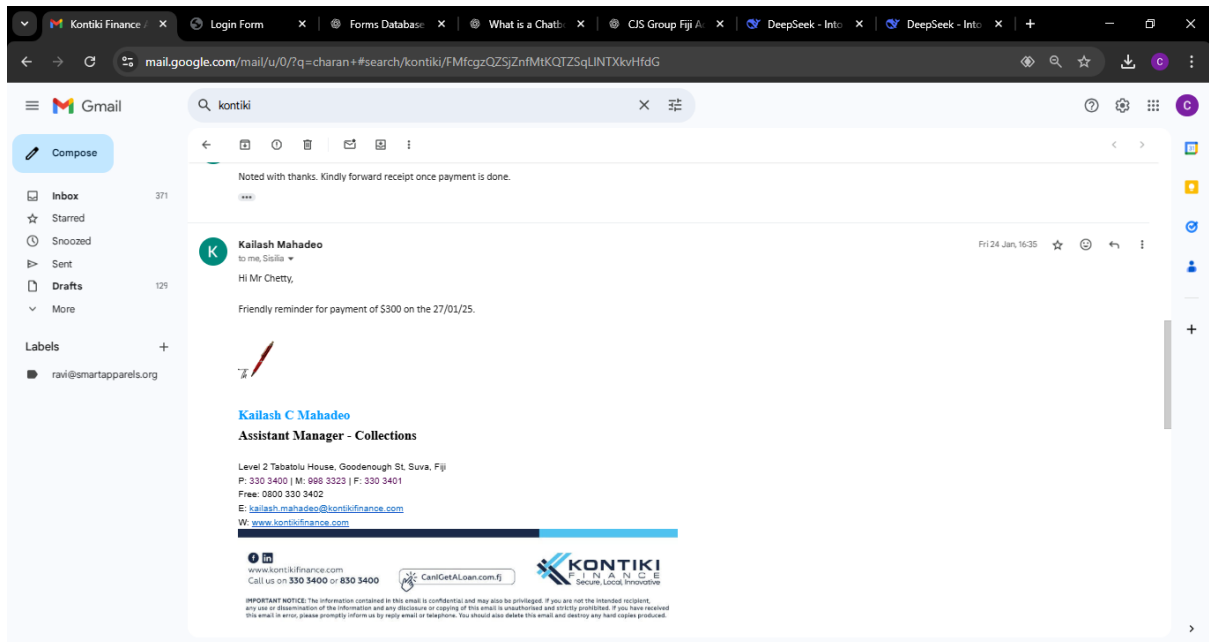

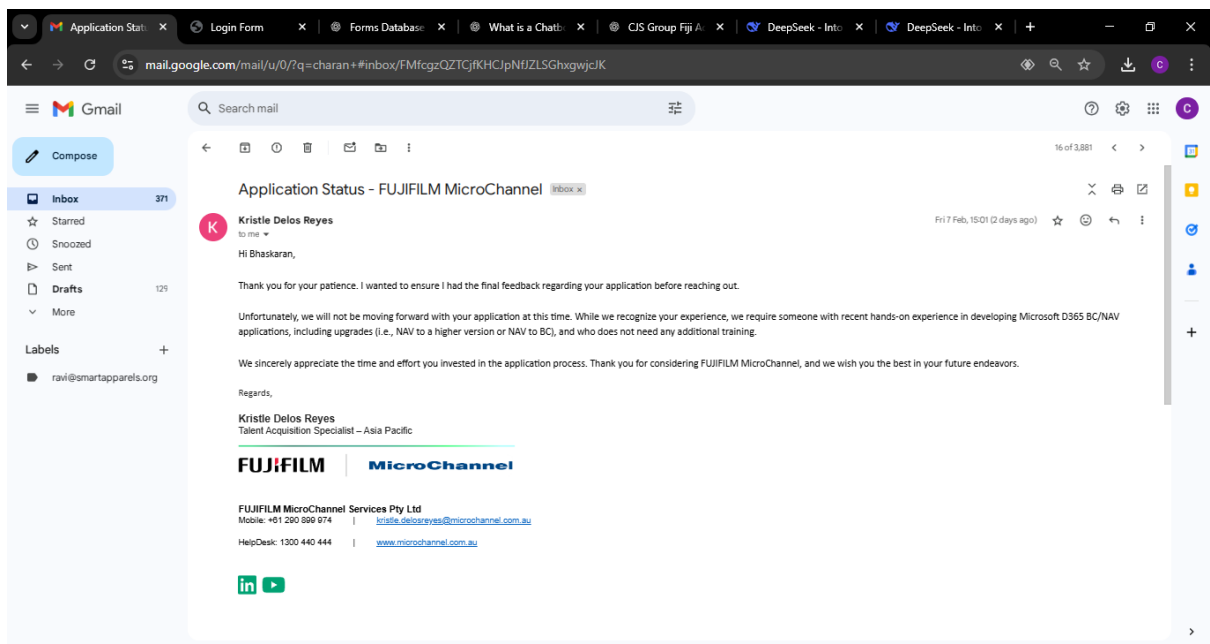
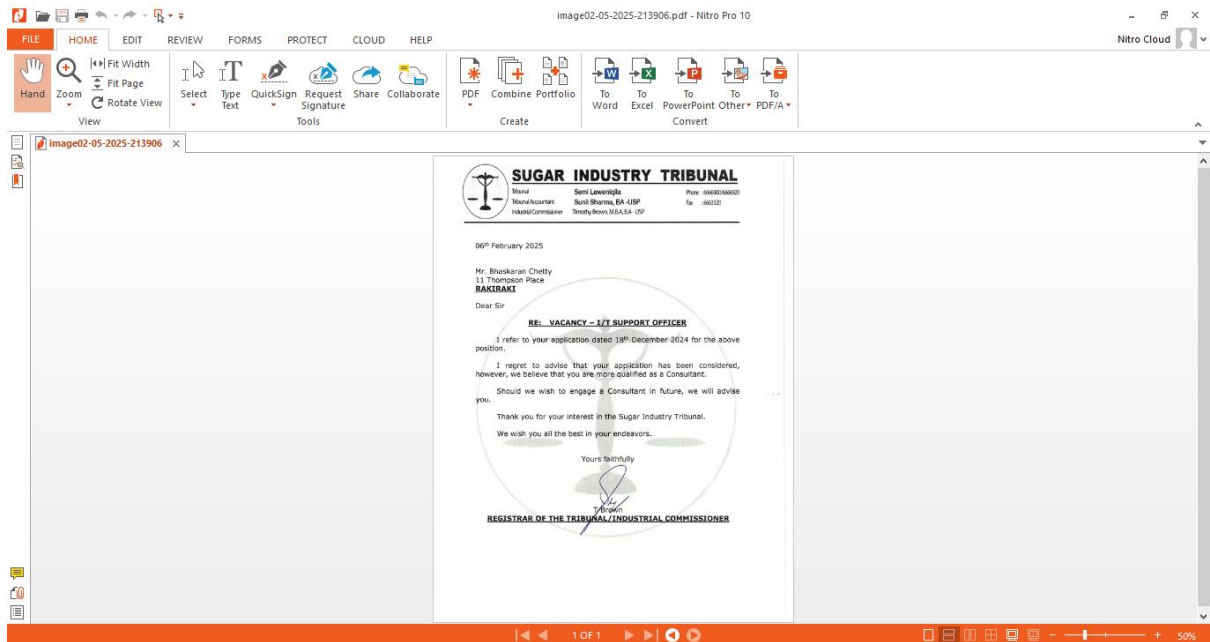


## Notice from Dominion Finance
